TORRE #1

WHEREAS, the Village of Williamsville applied for financial assistance from the State and Municipalities (SAM) Grant from the Dormitory Authority State of New York (DASNY) for the purpose of funding the renovations at the Municipal Building, including improvements to ADA accessibility; and

WHEREAS, the Village of Williamsville is authorized and directed to accept these grant funds in an amount not to exceed \$325,000.00 for the project described in the grant application; and

WHEREAS, the Village of Williamsville is authorized and directed to agree to the terms and conditions of the grant agreement with the Dormitory Authority of the State of New York (DASNY) for the renovations at the Municipal Building, including improvements to ADA accessibility; and

WHEREAS, the Village of Williamsville commits to making available the full amount of \$325,000.00 from the Village's general fund for the proposed project, with the understanding that funds will be reimbursed; and

WHEREAS, the Village of Williamsville is authorized and directed to agree to the terms and conditions of any required title to real property owned by the municipality and improved by the grant funds, which may be a duly recorded public access covenant, conservation easement, environmental review, permitting, and/or preservation covenant;

THEREFORE, BE IT RESOLVED, that the Village of Williamsville Board of Trustees hereby authorizes and directs the Mayor to sign and execute the contract agreement and any amendments thereto.
