ON MOTION by Mayor Kuzon, seconded by Trustee Brenton, the following resolution was adopted:

RESOLVED that the Village Clerk publish Notice of Public Hearing to be held January 12, 1981 at 7:30 p.m. in the Municipal Building, 5583 Main Street, Williamsville, New York for the purpose of hearing all persons interested in a local law which would extend the term of office of the Mayor and Trustees from two years to four years and set the dates of election to the odd years effective with the election held in 1983.

Increase term of Mayor and Trustees to four years

Unanimously carried.

ON MOTION by Trustee Atkinson, seconded by Trustee Brenton, it was moved to return to the regular agenda.
