Abstract of Local Law No. 1 of 1981 with respect to extending the terms of
 office of the Mayor and all Trustees to four years, to be submitted as Proposition
 No. 1 to the electors of the Village of Williamsville at the next Village Election
 to be held on the 17th day of March, 1981.

The purpose and effect of said local law is to extend to four years the terms
 of office of the mayor and all trustees of the Village.

The two trustees to be elected in 1982 will be elected for a three year term.
