WHEREAS, the Village of Williamsville has been awarded funding through the New York State Office of Parks, Recreation and Historic Preservation Environmental Bond Act Municipal Parks and Recreation Grant Program, and

WHEREAS, this funding will support the implementation of the Garrison Park Wading Pool and Bath House Project, which will provide improved recreational amenities for Village residents at the lowest possible cost to the Village and its taxpayers, and

WHEREAS, the total project cost is \$947,500, of which the State has awarded \$852,750 (90%) in grant funds, and the Village will provide \$94,750 (10%) in matching funds to satisfy the requirements of the funding program,

NOW, THEREFORE BE IT RESOLVED, that Christine Hunt, as Mayor of the Village of Williamsville, is hereby authorized and directed to accept the awarded funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of the Clean Water, Clean Air, and Green Jobs Environmental Bond Act of 2022, and to enter into and execute a project agreement with the State for such financial assistance for the Garrison Park Wading Pool and Bath House Project, and be it further

RESOLVED, that the Village Board authorizes the Mayor to execute all documents, contracts, agreements, amendments, required deeds of easement, and any other related materials necessary to carry out the implementation of the Garrison Park Wading Pool and Bath House Project in accordance with the terms of the award.

WHEREAS, said Board of Trustees find such account to be a true transcript and has certified to the effect that they have compared it with the original tax roll and find it to be correct.

NOW, THEREFORE, BE IT RESOLVED, that the Administrator of the Village of Williamsville is hereby credited by this Board of Trustees with the amount of said account in said return; and
